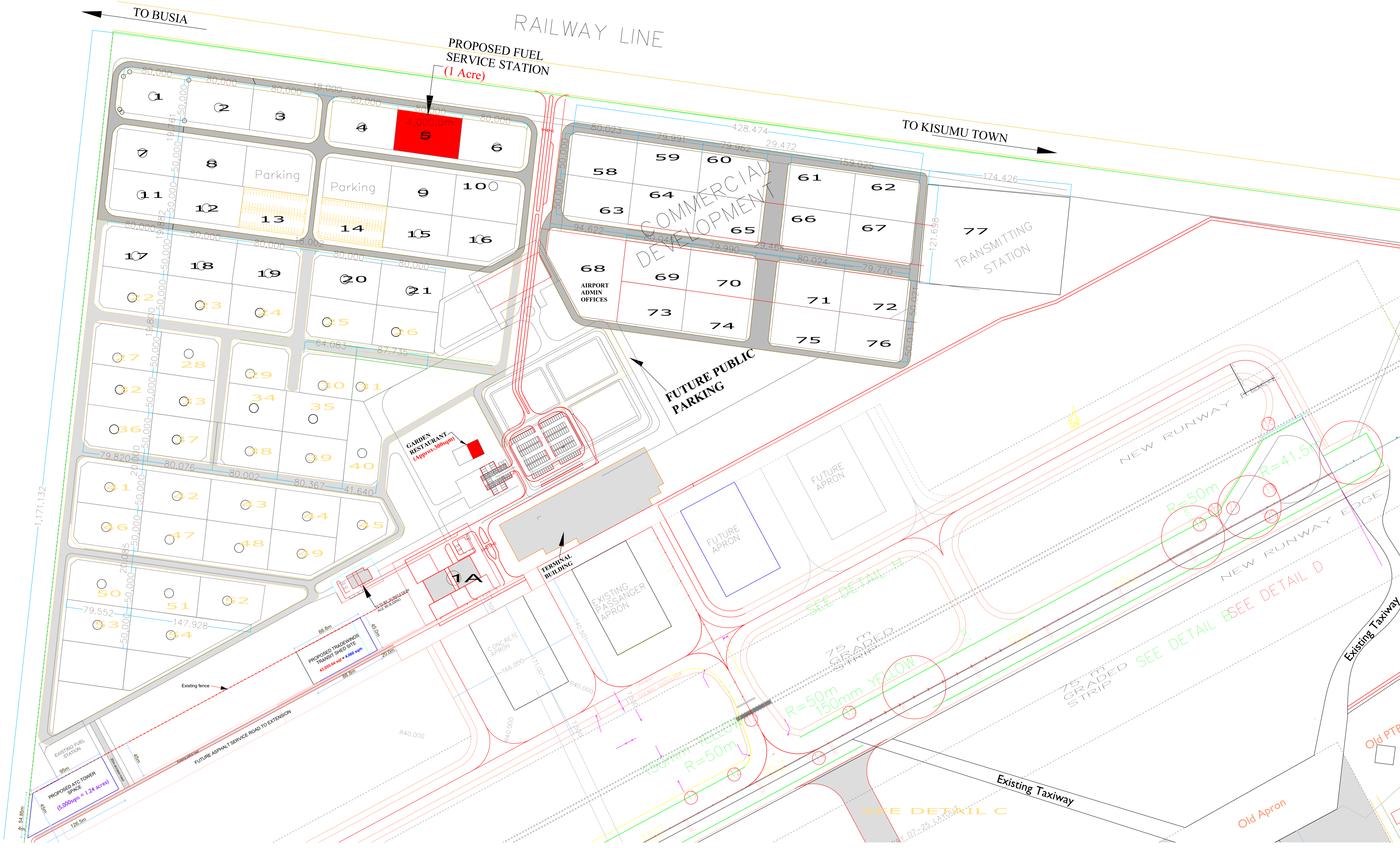
The closing/opening date has been extended to be **13th August, 2020** from **5th August, 2020** at the same time and place as per the Tender Document.
