1.	The drivers with the new driver's license (the card ) does not have any Endorsement dates on it, Kindly advise on how to prove the number of years in such an instance.	In the event that one has the new drivers licence and bidder is successful, due diligence will be carried out from National Transport and Safety Authority (NTSA) before award.
2.	Secondly kindly address the issue of Academic certification, we have drivers with even over 10-15 years' experience but don't have their KCSE certification, we would request exemption of Academic certification for drivers of over 50 years of age.	The minimum academic qualification is D+ and above in KCSE (or equivalent) and proficiency in English & Kiswahili
3.	Lastly we would request we have 1 driver per vehicle as they go home after their days tasks.	The minimum number of drivers expected due to the expected level of service at the airport is 2 per taxi
