



**REQUEST FOR EXPRESSIONS OF INTEREST (EOI) FOR PROVISION OF  
CONSULTANCY SERVICES FOR DESIGN AND TENDER DOCUMENTATION  
OF GROUND AND SLOPES STABILIZATION WORKS AT MOI  
INTERNATIONAL AIRPORT (MIA), MOMBASA**

1. Kenya Airports Authority intends to undertake detailed ground investigations and carry out detailed engineering designs for ground and slope stabilization at Moi International Airport.
2. The consultancy assignment will be carried out at Moi International Airport (MIA), Mombasa and the immediate surrounding areas.
3. The consultancy services will include:-
  - a) Geotechnical investigations for ground/slope stability studies;
  - b) Hydrogeological studies;
  - c) Review existing investigation reports;
  - d) Detailed engineering design;
  - e) Development of Specifications;
  - f) Preparation of Drawings;
  - g) Preparation of Bill of Quantities;
  - h) Preparation of Bidding and Contract Documents;
  - i) Provision of assistance during tender; and
  - j) Capacity building and technology transfer.
4. The consultancy period is expected to take no more than 6 months and will involve extensive stakeholder consultations, research and collaboration with other government agencies and departments.
5. The Kenya Airports Authority now invites eligible consulting firms ("Consultants") to express their interest in providing the services. Interested consultants should provide information demonstrating that they have the requisite qualifications and relevant experience to perform the services (in the form of a detailed company profile, description of similar assignments, experience in similar conditions, technical and managerial capabilities, core business and years in business, availability of appropriate skillset among others).
6. To be shortlisted, bidders are required to demonstrate:

- i) Successful completion of consultancy assignments of at least three (3) large and complex geotechnical engineering investigation projects in the last seven (7) years each with a value not less than Ksh.100 Million.
  - ii) Three (3) of the above must be in a coastal/marine environment and in Africa.
  - iii) Availability of an appropriate skills mix among proposed staff.
- 7. DO NOT submit financial statements at this stage.
  - 8. Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. Individual sub-consultants or firms shall only be allowed to participate in not more than one joint venture firm.
  - 9. The expression of interest document should not exceed 50 Pages.
  - 10. Interested bidders may obtain further information at the address below during office hours (weekdays from 08:00Hr to 17:00 Hrs EAT from Monday to Friday excluding lunch hour (13:00 to 14:00 Hrs) and public holidays.
