This service is expected to not only improve the image of the airport but also the overall customer experience

Kenya Airports Authority (KAA) hereby invites Expressions of Interest from qualified and reputable firms to develop CIP and manage CIP lounges at Moi International Airport (MIA), Kisumu International Airport (KIA) and Eldoret International Airport (EIA).

Objectives and Scope

The **objectives** of engaging reputable companies are: -

- Develop, manage and maintain lounges at MIA, KIA and EIA Airports
- To promote customer focus, integrity and professionalism within the legislated legal framework.
- To ensure international best practices in airport safety and security as well as environmental standards are observed at JKIA.

Criteria for short-listing

- a. Firms to demonstrate that they have legal capacity by submitting copies of:
 - Certificates of Incorporation / Registration.
 - CRI2
 - Valid Tax Compliance
- b. Provide a detailed company profile, including statements on its key business, business affiliations and networks, administrative and contact information.
- c. Firms to demonstrate that they are undertaking or have previously undertaken a project for development, management and operations of a related/similar business entity within hospitality, aviation hub, 4 star and above in the hotel sector.
- d. Access to a line of credit of not less than USD500,000, bank statement and overdraft facility specific to this tender.
- e. Firms to provide at least three (3) letters of recommendation and agreements/contracts from current clients within a period of the last three years.

After the shortlisting is completed, Requests for Proposals (RFPs) with specific Mandatory, Technical and Financial requirements will be issued.
